



### DIRECTIONS FOR USE

**SOIL APPLICATION RECOMMENDATIONS:** NEXUS ZINC 9% EDTA is recommended for use on all types of soils. Because this is a concentrated solution, it should be diluted before use to ensure uniform coverage. This dilution may be made in fertilizer solutions, water, or with compatible pesticides (use the standard jar test to determine compatibility). Soil applications may be made through irrigation systems or in band or broadcast fertilizer applications.

**Rates:** Product should be applied at rates from 2.5 to 10 liters/hectare (1 to 4 liters/acre).

**FOLIAR APPLICATION RECOMMENDATIONS:** NEXUS ZINC 9% EDTA may be applied in water or in combination with most pesticides. Avoid applying this product when plants are suffering from moisture stress. If there is any doubt, apply the spray solution to a small test area of the crop or foliage to assess any undesirable effects or phytotoxicity before general application.

**Rates:** Apply with enough carrier to thoroughly cover all foliage. Product should be applied at rates from 1.25 to 2.5 liters/hectare (0.5 to 1 liter/acre).

**AERIAL APPLICATION:** Apply 0.50 to 1.0 liter of NEXUS ZINC 9% EDTA per hectare in at least 35 liters of water.
